**RE: APPROVAL REGISTERED ASBESTOS CONTRACTOR** 

I have pleasure in informing you that your organization has been approved as a Registered Asbestos Contractor subject to the following conditions:

- The approval is granted only with respect to the services stipulated on the application.
- Your approval is valid for a period of 12 months from 03 February 2015
- All operational staff involved in asbestos work must be appropriately trained and have undergone medical examination.
- Minimum health and safety requirements, as well as any instruction that may be issued by the Chief Inspector, must be complied with at all times.
- The approval is subject to instant withdrawal by the Chief Inspector for failure to comply with the aforementioned conditions.
- You are reminded that in accordance with regulation 3 of the Asbestos Regulations 2001, asbestos work may only be carried out once the provincial director of the Department of Labour has been notified in writing prior to the commencement of such work.
- Thirty (30) days prior to the commencement of any demolition work a written plan of work shall be submitted to the approved asbestos inspection authority for approval.
- A copy of the approved plan of work should be submitted to the provincial director of the Department of Labour at least 14 days prior to commencement of asbestos work. A list of contact details for provincial directors is available in table 1.
